

Terms and conditions governing the Great Eastern App TravelSmart Premier Flash Deal Campaign (May 2024)

1. Eligibility

- 1.1. The Great Eastern TravelSmart Premier Flash Deal Campaign (May 2024) promotion (the “Promotion”) is organised by Great Eastern General Insurance Limited (“GEG”).
- 1.2. It will be held from 1 May 2024 to 15 May 2024, both dates inclusive (the “Promotion Period”).
- 1.3. This Promotion is applicable to the first 300 TravelSmart Premier Elite and Classic single trip plans and the first 100 TravelSmart Premier Elite and Classic annual multi-trip plans purchased via the Great Eastern App by individuals between 1 May 2024 to 15 May 2024 (“Eligible Customers”), provided:
 - a. The policy is not subsequently cancelled.
 - b. The purchase is made via Great Eastern App. Manual application(s) will not be eligible.
 - c. The policy purchased is a new policy sign up. Renewal of existing TravelSmart Premier annual multi-trip plan policy and replacement policies will be not eligible.

2. Promotion Mechanics

- 2.1. Eligible Customers shall be eligible to receive the GREAT Dollars (“**Reward**”) as per the table below and the GREAT Dollars will be credited to the Eligible Customer’s Great Eastern Rewards (“GER”) mobile application account within six weeks after the end of the Promotion Period.

- 2.2. Only the main policyholder will be eligible for the Reward.
- 2.3. This Promotion is strictly non-transferrable.
- 2.4. This Promotion cannot be used in conjunction with any other General Insurance promotion unless otherwise advised by GEG.

3. Notification and Redemption of Reward

- 3.1. Eligible Customers will be notified by email, as provided to GEG at the point of purchase of the policy, within six weeks from the end of the Promotion Period on qualifying for the Reward.
- 3.2. Eligible Customers are required to download the GER mobile application and register for an account using the same email address provided to GEG at the point of purchase to receive the Reward.
- 3.3. The Reward including any unused value cannot be exchanged for cash, kind, or other denominations and are subject to additional terms and conditions imposed by the third-party merchant.
- 3.4. Once the Reward has been credited to Eligible Customer's GER mobile application account, customers will not be allowed to cancel their policies. Should the policy(s) be cancelled, the Eligible Customer shall return the full voucher value of S\$20 or S\$50 to GEG.

4. General

- 4.1. GEG reserves the right at its sole and absolute discretion to terminate the promotion or make changes to the promotion or any of these terms and conditions at any time without notice.
- 4.2. The decision of GEG on all matters relating to this promotion shall be final and binding.
- 4.3. The terms and conditions of this promotion shall be governed by and interpreted in accordance with Singapore law. The courts of Singapore shall have exclusive jurisdiction over any disputes arising from the terms and conditions, including the validity and enforceability thereof.
