<ul style="list-style-type: none"> Do stay calm, park the vehicle in a safe position and location, and exit the vehicle safely 	<ul style="list-style-type: none"> Do not admit liability or responsibility to anyone, verbally or in writing
<ul style="list-style-type: none"> Do check to see if anyone is injured and if so, call 999 for the police to summon medical assistance and ambulance 	<ul style="list-style-type: none"> Do not fall prey to touts and strangers who may offer help at the scene
<ul style="list-style-type: none"> You may contact our 24-hour emergency assistance through: <ol style="list-style-type: none"> Assistance Hotline Number: +65 6535 0511 Whatsapp: +177 5508 5777 Click to call: https://emakl.3cx.com.my:5001/greasternauto 	<ul style="list-style-type: none"> Do not allow your damaged and immobilized vehicle to be towed away by non-authorized workshop's tow truck
<ul style="list-style-type: none"> Do exchange vehicle and driver particulars as follows whilst waiting at the scene: <ol style="list-style-type: none"> Registration number of all vehicles involved in the accident (including color, make, and model if you can identify) Driver's name, and mobile number of all vehicles involved, The number of passengers in the vehicles If a camera is on hand, take pictures of the position and damage condition of the vehicles involved 	<ul style="list-style-type: none"> Do not accept any offer of repair and claim services by workshop not on our list of authorized workshops
<ul style="list-style-type: none"> Do report the accident within 24 hours from the time of accident at one of our authorized workshop and provide all factual information and details so that your accident report may be filed accurately and timely 	<ul style="list-style-type: none"> Do not accept any promises, waiver of Excess, and / or offer of free use of a courtesy car from strangers, including drivers involved in the accident, at the scene of accident
<ul style="list-style-type: none"> Do provide our authorized workshop with the photographs you have taken of the vehicles involved for upload into your report 	<ul style="list-style-type: none"> Do not attempt to sort out who was at fault with the Third Parties at the scene
<ul style="list-style-type: none"> Do accept our authorized workshop offer of repair 	<ul style="list-style-type: none"> Do not accept lawyer services arranged by Workshop
<ul style="list-style-type: none"> Do allow our authorized workshop to assist you in claiming against the responsible Third Party if you are not at fault 	<ul style="list-style-type: none"> Do not sign on any papers presented to you by anyone without first reading and understanding it especially on the fine prints
<ul style="list-style-type: none"> Do allow our authorized workshop sufficient time to carry out a quality repair work 	<ul style="list-style-type: none"> Do not delay in reporting the accident to our authorized workshop as there is a NCD penalty if accident is not reported within 24 hours from the time of accident, and your claim / indemnity under the policy may be prejudiced as a result
<ul style="list-style-type: none"> Do check your repaired vehicle on collection for any defective repairs
