 - a. Purchased any of the GREAT EV Protect plan via the yuu App (the "**Plan**").
2. By purchasing the Plan within the Campaign Period, each Eligible Member agrees to be bound by these Terms and Conditions.
3. Every "Successful Purchase", defined as after the 2 weeks' free look period of the Plan, will each qualify to receive a S\$50 worth of Charge+ credits (the "**Prize**") on a while stocks last basis.
4. The plan must not be cancelled within 2 weeks after the end of the Campaign Period.
5. The decisions of GE on all matters relating to this Campaign are at its discretion and are final, conclusive and binding. GE shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter concerning this Campaign or its decision and no appeal, correspondence or demands or claims will be entertained and no payment or compensation will be given or paid by GE or shall not be liable to any party.

Without prejudice to this clause, to the fullest extent permitted by law, yuu Rewards Club excludes all liability for any loss or damage whatsoever suffered (including, without limitation, indirect or consequential loss), or for personal injury suffered or sustained in connection with the Campaign or as a result of issuance, receipt and use of, or otherwise in connection with any of the Prizes.

You (including your heirs, executor and/or administrators) hereby agree to indemnify fully and hold yuu Rewards Club and its directors, officers, employees, and assignees or any other associated sponsors thereof (the "Indemnified Parties") harmless from and against any and all claims, losses, liability or damages (including but not limited to economic loss, damage to any property or injury to or death of any person and any legal costs) that may be suffered or incurred by any of the Indemnified Parties arising whether directly or indirectly from:

- a. any negligent act or omission or willful default, misconduct or fraud by you; or
 - b. any action, claim, loss, damage, cost and expense whatsoever brought against, suffered or incurred arising from or in connection with any breach of the terms and conditions hereunder (including, without limitation to the generality of the foregoing, a breach of the representations, warranties, undertakings, agreements or acknowledgements hereof) by you.

Neither yuu Rewards Club nor yuu Rewards Club's employees, affiliates, representative offices, authorized agencies or any other associated sponsors associated with the Campaign shall be held liable for any delay, cancellation, failure or omission to carry out the Campaign in accordance with these terms and conditions or for any loss or damage suffered by you in relation to the Campaign or your participation therein, including where such delay, cancellation, failure, omission, loss or damage arises out of or in connection with any event of force majeure, including without limitation any calamity or conditions, Acts of God, war or warlike hostilities, civil commotion, riots, blockades, embargoes, sabotages, strikes, fires, lockouts, shortages of material or labor, terrorist activity, outbreaks of disease (epidemic or otherwise), quarantine restrictions, health risk or any defect, failure, or any other occurrence beyond the reasonable control of yuu Rewards Club, yuu Rewards Club's employees, affiliates, representative offices, authorized agencies or any sponsor associated with the Campaign, as the case may be.
18. In the event of any inconsistency between these terms and conditions and any brochures, marketing or other promotional materials or communications relating to the Campaign, these terms and conditions shall prevail.
19. The terms and conditions of this Campaign shall be governed by and interpreted in accordance with Singapore law. The courts of Singapore shall have exclusive jurisdiction over any disputes arising from the terms and conditions, including the validity and enforceability thereof.
