PayNow Option</p> <ul style="list-style-type: none"> <li>Applicable only to SGD-denominated policies.</li> <li>You must have your Singapore NRIC/FIN linked to your bank account.</li> <li>By selecting PayNow, you authorise the Company to deposit payments into your linked account and consent to necessary data sharing for verification.</li> </ul> <p>3. Crediting to Bank Accounts</p> <p>A. <u>Singapore Bank Account:</u></p> <ul style="list-style-type: none"> <li>Provide a recent (within 6 months) bank statement/passbook/e-statement showing your full name, ID/address, bank name, and account number (with other details blanked out).</li> <li>If there are changes to your personal particulars, please submit the Update of Personal Particulars form together with this request.</li> </ul> <p>B. <u>Overseas Bank Account:</u></p> <ul style="list-style-type: none"> <li>Provide a recent (within 6 months) bank statement/passbook/e-statement showing your full name, ID/address, bank name, and account number (with other details blanked out).</li> <li>Submit a clear copy of your valid identification card/passport (minimum 6 months validity).</li> <li>Submit a clear copy of your valid employment pass, work permit, student pass, or dependent's pass (front and back).</li> <li>Provide a recent (within 6 months) utility or phone bill showing your full name and address (with other details blanked out).</li> <li>If there are changes to your personal particulars, please submit the Update of Personal Particulars form together with this request.</li> </ul> <p>4. Currency of Transactions</p> <ul style="list-style-type: none"> <li>All transactions will be conducted in the policy currency. Policyholders will have to bear any charges incurred if the transacting bank is not of the same currency or if they request to transact in a different currency.</li> </ul>
