## Terms and Conditions for 2025 Reach for GREAT Colouring Contest

- 1. The 2025 Reach for GREAT Colouring Contest ("Colouring Contest") is organised by The Great Eastern Life Assurance Company Limited ("Organiser") and is open to children aged between Three (3) to Six (6) years ("Contestant(s)"), living in Singapore.
- The Colouring Contest period is between 26 August 2025 to 16 November 2025 ("Contest Period"). The Organiser reserves the absolute right to shorten or extend the Contest Period if deemed necessary without prior notice. Entries received after the Contest Period will not be entertained.
- 3. Registration for the Colouring Contest is open to individuals who are Singapore Citizens, Singapore Permanent Residents or dependents of pass/permit holders residing in Singapore with a valid Singapore mailing address and employment pass or work permit.
- 4. The Colouring Contest mechanics are as follows:
  - a) Parents and legal guardians (the "Applicants") are required to download the Colouring Contest form and register their particulars via <a href="https://go.greateasternlife.com/colouringcontest2025">https://go.greateasternlife.com/colouringcontest2025</a>. Contestant(s) are to colour and draw/complete the colouring template in the Colouring Contest entry form. Entries without completed information will not be accepted.
  - b) Entries are to be submitted via <a href="https://go.greateasternlife.com/colouringcontest2025">https://go.greateasternlife.com/colouringcontest2025</a>.
    - i) Maximum of 8MB per submission, file formats accepted: .png, .jpg, .pdf.
    - ii) Attachment filename format will be as follows: Full\_Name\_of\_Child,Age i.e. Tan\_Li\_San\_Thea,5
    - iii) Applicants will receive an acknowledgement email from Great Eastern after they have sent in their completed colouring template.
    - iv) Applicants must fulfil all the mechanics as set out in these terms and conditions during the Qualifying Period to qualify for the Colouring Contest (each an "Eligible Applicant", collectively "Eligible Applicants").
- 5. Each Applicant can only register once for the Colouring Contest. If an applicant submits more than one registration form, only the first duly completed registration form received by Great Eastern will qualify.
- 6. Judging criteria:
  - a. Contestant(s) entries for each Contestant will be judged based on creativity and completion of colouring.Contestant(s) may add additional drawings in the colouring section, but it must not contain copyrighted work and must be of an original content/creativity.
  - b. Any colouring tools may be used, including but not limited to colour pencils, crayons, markers, and watercolours.
  - c. Contestant(s) must complete the colouring portions of the Contest entry form by themselves without the assistance from any third party.
  - d. All Contest entry forms must be completed in full and submitted by a parent or legal guardian. The Organiser reserves the right to disqualify entries with invalid or incomplete details.
  - e. All entries must be received by the Organiser on or before the end of the Contest Period.

- 7. Pictures of the Contest entry forms following certain criteria are accepted:
  - a) Image is well lit.
  - b) Image is clear and is high in resolution.
  - c) Original of the submitted Colouring Contest entry form should be retained by the Contestant(s) till 30 November 2025 for the purpose of validation and qualification.
- 8. The Organiser shall not be liable or responsible for any delay and/or failure in the receipt of the entry forms.
- 9. The Organiser is not liable or responsible for any late, lost, incomplete, incorrectly submitted, delayed or misdirected entries.
- 10. The Organiser reserves the right to disqualify entries (at any stage of the Contest) that do not meet the Contest mechanics and/or have invalid or incomplete details. All decisions made by the Organiser are final and the disqualified Contestant(s) will accordingly have no recourse and/or remedy and/or relief against the Organiser in respect of the said disqualification and/or in respect of any matters relating to and/or arising from this Contest, including the forfeiture of Prizes.
- 11. All entries shall become the absolute property of the Organiser and may be used for marketing purposes.
