Resolutions 3(i), (ii), (iii) and (iv)

Resolutions 3(i), (ii), (iii) and (iv) are to re-elect Directors who are retiring by rotation under article 97 of the Company's Constitution. Mr Koh Beng Seng will, upon re-election, continue to serve as Chairman of the Board, the Executive Committee and Risk Management Committee, respectively, and a

Mr Law Song Keng will, upon re-election, continue to serve as a Member of the Audit Committee, the Executive Committee and the Risk Management Committee,

Mr Soon Tit Koon will, upon re-election, continue to serve as a Member of the Risk Management Committee.

Mr Thean Nam Yew will, upon re-election, continue to serve as a Member of the Audit Committee and the Executive Committee. respectively.

Ernst & Young LLP has served as the external Auditor of the Company since the Company's incorporation in 1999 and will not be seeking re-appointment at the AGM. The Company had previously disclosed in its Annual Report 2018 that the Audit Committee has nominated PricewaterhouseCoopers LLP for appointment as the external Auditor of the Company in place of Ernst & Young LLP for the financial year ending 31 December 2020. The nomination was made following a tender process

based on an established framework for the selection of an external auditor. Please refer to the Letter to Shareholders dated 23 March 2020 and the "Principle 10: Audit Committee" section in the Corporate Governance Report on page 90 in the Annual Report 2019 for more details. Resolution 6 is to authorise the Directors of the Company from the date of the AGM until the next annual general meeting to issue shares of the Company and to make or grant instruments (such as warrants or debentures) convertible into shares on a pro rata basis to shareholders of the Company, and to issue shares in pursuance of such instruments, up to a number not exceeding 50% of the total number of issued shares of the Company (excluding treasury shares and subsidiary holdings). For the

purpose of determining the aggregate number of shares that may be issued, the total number of issued shares of the Company (excluding treasury shares and subsidiary holdings) shall be based on the total number of issued shares of the Company (excluding treasury shares and subsidiary holdings) at the time this proposed Ordinary Resolution is passed, after adjusting for (a) new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which were issued and are outstanding or subsisting at the time this proposed Ordinary Resolution is passed, and (b) any subsequent bonus issue, consolidation or subdivision of shares. For the avoidance of doubt, any consolidation or subdivision of shares of the Company will require shareholders' approval. The Directors will only issue shares and instruments under this Resolution if they consider it necessary and in the interests of the Company. As at 28 February 2020, the Company had no treasury shares and no subsidiary holdings. The Company also reserves the right to take such precautionary measures as may be appropriate at the AGM in view of the evolving COVID-19 situation, including any precautionary measures as may be required or recommended by government agencies, in order to minimise the risk of community spread of COVID-19. Such measures may include the following:

- 1. All persons attending the AGM will be required to undergo a temperature check and sign a health & travel declaration form (which may also be used for the purposes of contact tracing, if required).
- 2. Any person who has a fever or is exhibiting flu-like symptoms will be declined entry to the AGM. Shareholders and other attendees who are feeling unwell on the date of the AGM are advised not to attend the AGM. Shareholders and other attendees are also
