## We will reimburse you as an employer:

- **Up to S\$30,000 for Hospital and Surgical Expenses** if the Foreign Domestic Worker (FDW) needs to stay in hospital as a result of injury or illness caused or arising during the period of insurance.
- **Up to S\$3,000 for Medical Expenses** which you have to pay in connection with an injury that the FDW receives and requires treatment from a medical practitioner resulting from an Accident.
