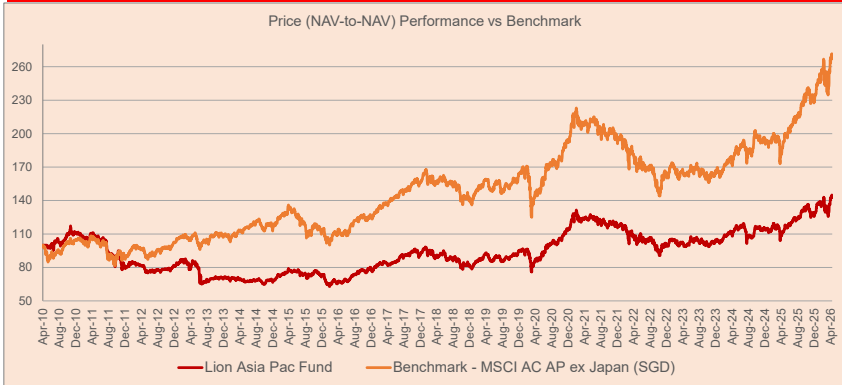


**Fund Objective**
