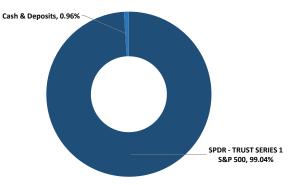

Market Outlook

Key index performances in the U.S. were back to positive, where the Dow Jones was up by 3.9% M/M, the S&P 500 improved by 6.2% M/M, and the Nasdaq surged by 9.6% M/M. Global markets extended their recovery in May, building on April's lows as consumer sentiment improved and trade tensions eased. Progress in U.S. trade negotiations with the E.U. and a temporary delay to planned tariff hikes reduced fears of a global recession and fueled broad-based gains across risk assets. U.S. stocks have outperformed most of their global peers in May.
