

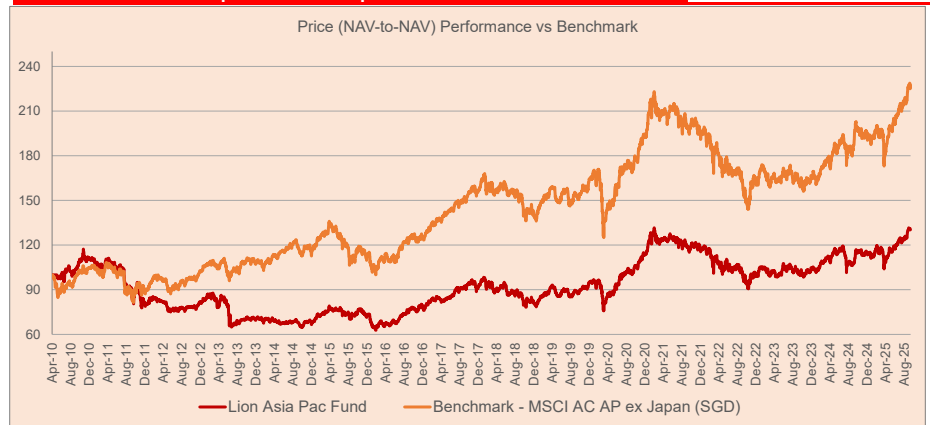
## Fund Objective
