

### **Terms & Conditions Governing The Great Eastern Plan Like A Woman “Register and Win” Promotion**

These terms and conditions govern the **R&W Promotion**. Participation in the **R&W Promotion** constitutes acceptance of these terms and conditions as set out herein, including all amendments, additions, replacements and modifications hereto as may from time to time be made by **Great Eastern**.

1. The Great Eastern Plan Like A Woman “Register and Win” Promotion (“**R&W Promotion**”) is organised by The Great Eastern Life Assurance Company Limited (“**Great Eastern**”) and is open to the Qualified Participants from 6 June 2019 to 5 September 2019 (both dates inclusive) or such other time that **Great Eastern** may determine at its sole discretion (“**Qualifying Period**”).
2. The following term as used in the **R&W Promotion** shall have the following meaning:
  - a. “**Qualified Participant(s)**” refers to the participant(s) who has/have taken part in the **R&W Promotion**, and has/have met all the required criteria of this **R&W Promotion**.

### **Mechanics**

3. An individual must fulfil all the mechanics as set out in these terms and conditions to qualify for the **R&W Promotion** as a Qualified Participant:
  - a. During the **Qualifying Period**, fill in the Great Eastern Plan Like A Woman Promotion online registration form that is found on [GreatEasternLife.com](http://GreatEasternLife.com) with his/her personal particulars as required, tick the box indicating participation in the **R&W Promotion**, complete with full marketing consent for the collection, use and disclosure of his/her personal data for the specified purposes.

Participants must ensure that their particulars registered are true, complete and accurate in all respects, and that **Great Eastern** may rely on the information of this registration to contact them for the specified purposes (For example, at registration, the participants must provide their respective registered mobile numbers and valid email addresses which may be used by **Great Eastern** for the purpose of sending the details of promotion(s)). Each mobile number and email address can only be used once for the registration. In the event that one mobile number and/or one email address is/are entered more than once in the registration forms, only the first duly completed registration form received by Great Eastern will qualify.

- b. This **R&W Promotion** is open to only individuals who are Singapore Citizens, Singapore Permanent Residents or foreigners with a valid employment pass or work permit. Employees of **Great Eastern** are not eligible for the **R&W Promotion**.

### **Rewards**

### Collection of Rewards

6. **Qualified Participants** who are eligible for the **Rewards** will be notified via electronic mail (EDM) and the **Great Eastern** UPGREAT mobile application (“**UPGREAT App**”) within 6 weeks from the date of their respective registrations. The EDM will be sent to these **Qualified Participants’** respective email addresses as indicated in the registration forms.
7. The eligible **Qualified Participants** are required to download the UPGREAT App and register for an account using the same email address provided during registration in order to receive the **Rewards**.
8. The relevant eligible **Qualified Participants** will need to show the notification regarding the **Rewards** in the UPGREAT App at the specified location to collect the **Rewards**.
9. The eligible **Qualified Participants** shall not be entitled to any compensation, benefits or substitution in any form whatsoever in lieu of the **Reward** and/or should any **Reward** be forfeited or reclaimed.

### General

10. The **Great Eastern** will have the final decision on all matters regarding the **R&W Promotion**.
11. The **Great Eastern** may vary these terms and conditions or suspend or terminate the **R&W Promotion** without any notice or liability to any party.
12. In the event of any inconsistency between these terms and conditions and any advertising, publicity, brochure, marketing or other materials relating to or in connection with this **R&W Promotion**, these terms and conditions shall prevail.
13. The **Great Eastern** makes no representation to the quality or performance of the **Rewards** provided by the merchants/ partners/ vendors in connection with the **R&W Promotion**.
14. **Great Eastern** will not be responsible for any injuries, loss, claim or damage suffered or incurred in connection with the **R&W Promotion**, the **Rewards** and/or any notices, letters or correspondence lost, stolen or misdirected in the postal system or telecommunication system, and the consequences arising from the non-receipt of such communication.
15. By participating in this **R&W Promotion**, the participants agree to release and hold **Great Eastern** harmless from any and all liability whatsoever for any injuries, losses or damages of any kind to any person or property arising from or in connection with, either directly or indirectly:
  - a. the awarding, acceptance, receipt, possession, use or misuse of any **Reward** or parts thereof awarded pursuant to the **R&W Promotion**; and
  - b. the participation in the **R&W Promotion** or any **Reward**-related activities.
16. Notwithstanding anything herein, **Great Eastern** has the absolute discretion to determine the eligibility of any person to participate in the **R&W Promotion**.
17. If **Great Eastern** subsequently determines that a person is in fact not eligible, for any reason whatsoever, **Great Eastern** may at its discretion, disqualify the participant without prior notice.

By participating in the **R&W Promotion**, each participant agrees and consents to **Great Eastern** and its related corporations (collectively, the “**Companies**”), as well as their respective representatives, agents, authorised service providers and relevant third parties (the **Companies** and all the other foregoing parties, collectively, “**Great Eastern Persons**”), collecting, using and/or disclosing each participant’s personal data, for purposes reasonably required by the **Companies** to administer the **R&W Promotion** and such other purposes as described in **Great Eastern’s** Privacy Statement which is accessible from **Great Eastern’s** website, which each participant confirms he/she has read and understood.

20. The terms and conditions of the **R&W Promotion** shall be governed by and interpreted in accordance with Singapore law. The courts of Singapore shall have exclusive jurisdiction over any disputes arising from the terms and conditions, including the validity and enforceability thereof.
