

Terms and conditions

1. Promotion is open to attendees of the KKH Webinar/Events. Promotion period is from 27 February 2021 to 31 December 2021 (both dates inclusive).
2. Each family, regardless of number of family members, can only register for a sharing session on how to invest in your child's future.
3. Successful registrants will receive a confirmation email within three (3) working days.
4. First 50 successful registrants who have completed the 20-min sharing session will receive 5,000 UPGREAT Points (which can be used to redeem a \$50 Mothercare voucher) and a Baby Kit ("**Gift**") from our financial representative.
